<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.65) Employee National Insurance (£38.04)</b>
<b>Any other deductions or costs from your wage:</b>	<b>None</b>
<b>Example net take home pay:</b>	<b>£410.31</b>

### EXAMPLE PAY

(where there is a Student Loan/Postgraduate Loan deduction)

All example pays are based on tax code 1257L W1/M1

Example rate of pay (incl. Holiday Pay):	£100.00 per day (which includes £10.77 of holiday pay)
Days worked	5
Gross Pay	£500.00
Deductions from your wage required by law:	Income tax (£51.65) Employee National Insurance (£38.04)
Any other deductions or costs from your wage:	None
Student Loan Plan 1	£11.44
Example net take home pay:	£398.87

If you have a Student Loan Plan 2, the following net pay would be:

Student Loan Plan 2	£0
Example net take home pay:	£410.31

If you have a Postgraduate Loan, the following net pay would be:

Student Loan Postgraduate Loan	£5.77
Example net take home pay:	£404.54

### EXAMPLE PAY

(where there is an Attachment of Earnings order being made)

All example pays are based on tax code 1257L W1/M1

Example rate of pay (incl. Holiday Pay):	£100.00 per day (which includes £10.77 of holiday pay)
Days worked	5
Gross Pay	£500.00
Deductions from your wage required by law:	Income tax (£51.65) Employee National Insurance (£38.04) Attachment of Earnings Order (£61.55)
Example net take home pay:	£348.76

### EXAMPLE PAY

(with pension contributions)

All example pays are based on tax code 1257L W1/M1

Example rate of pay (incl. Holiday Pay):	£100.00 per day (which includes £10.77 of holiday pay)
Days worked	5
Gross Pay	£500.00
Deductions from your wage required by law:	Income tax (£51.65) Employee National Insurance (£38.04) Pension contributions (£19.00)
Example net take home pay:	£391.31

### EXAMPLE PAY

(with DBS deduction)

All example pays are based on tax code 1257L W1/M1

Example rate of pay (incl. Holiday Pay):	£100.00 per day (which includes £10.77 of holiday pay)
Days worked	5
Gross Pay	£500.00
Deductions from your wage required by law:	Income tax (£51.92) Employee National Insurance (£39.72)
Example net take home pay:	£408.36
Deduction made for DBS	£46.60
